
**DEFICIENCY MEMO**

During the course of scrutiny of documents held on 19.12.2022, deficiencies regarding 'NCL before Cut-off date is required' and 'Subjects are not clear' were noticed and accordingly a Deficiency Memo No.F. DE.3(29)/DRC(E-III)/TGT/Natural Science (Male)/2022/844 was issued on 19.12.2022 in this regard. It is informed you that your case regarding main subject clearance has been placed before to a constituted expert committee by the Department for deciding whether you have studied any one main subject out of five subjects for two years or not according to the Vacancy Notice Advertisement No. 02/21 dated 12.05.2021 and matter is under consideration.

However, in the meanwhile, during the course of re-scrutiny of documents available in e-dossier (by Team members), in respect of Mr. **Avinash Kumar (Roll No: 112703500122)** for the post of TGT (Natural Science) - Male (Post Code 35/21), following deficiency has been noticed: -

1. Delhi based OBC Certificate is required, however, candidate have possessed **two** OBC Certificates i.e. OBC Certificate No. 90500000233882 dated 03.03.2017 issued by the SDM (Alipur), District – North, Delhi on the basis of OBC certificate issued to his sister – Deepa Kumari who belongs to KAHAR community of West Bengal State **and** another OBC Certificate No.90500000534137 dated 10.05.2019 issued by the Tehsildar (Alipur), District – North, Delhi on the basis of OBC certificate issued to self (Avinash Kumar) who belongs to KAHAR community of Delhi State vide Certificate No. 90500000233882 dt. 27.03.2017, **however**, Certificate No.90500000233882 was issued on 03.03.2017 **instead** of 27.03.2017 and caste community is KAHAR belongs to West Bengal State **instead** of Delhi State. Perhaps this is a typographical mistake, however, OBC Certificate dated 05.10.2019 is issued towards "For applying for appointment to Posts under the Government of India" and aforementioned both the OBC Certificates are not valid for the post of TGT (Natural Science) – Male, Post Code 35/21 according to Para Number 5, 6(ii), 6(iii), 6(iv) & 8(viii) of Vacancy Notice Advertisement No. 02/21 dated 12.05.2021

You are therefore directed to submit your clarification in person along with deficient/requisite documents in respect of above mentioned deficiencies to **Direct Recruitment Cell (E – III), Next Building from MP hall, Lancer Road School Complex, Behind Vishwavidyalaya Metro Station, Delhi - 110054** latest by 20/12/2023, failing which appropriate action towards cancellation of your candidature may be initiated as per prescribed RRs/Guidelines and Vacancy Notice Advertisement No. 02/21 dated 12.05.2021.
