Cancellation of offer of Appointment and candidature to the post of TGT(ENGLISH) FEMALE, Post Code 51/21

Whereas, **Ms. Koyel Banerjee, DoB 17.05.1990, Roll No. 112305100336, Category UR**, has been nominated by the DSSSB to the post of TGT (ENGLISH)-FEMALE against Post Code 51/21 vide Result Notice No. 1408 dated 20/07/2022 in the Directorate of Education, Govt. of NCT of Delhi and their e-dossiers received from DSSSB for further proceedings of appointment. During the Document verification, following deficiencies has been found:

1. NCTE Certificate is required.
2. The candidate has not studied Hindi Language.
3. First page of the Service Book attested by the HOO is required.
4. Copy of the Medical & Police Verification Report attested by HOO is required.
5. Entry of Appointment and Medical & Police Verification attested by HOO is required.

This office had issued a Deficiency Memo to **Ms. Koyel Banerjee** on 31.07.2023 and subsequent Reminder dated 21.08.2023, 29.09.2023 and 10.11.2023 to clear the deficiency. But no reply has been received in this office from **Ms. Koyel Banerjee** till date.

Accordingly, as the candidate has not submitted the requisite document/clarification in support of her candidature and not qualified as per the recruitment rules published in advt no. **03/21** issued by the DSSSB for the post concerned, hence, the Director of Education being the Competent Authority ordered to **cancel** the candidature of **Ms. Koyel Banerjee, DoB 17.05.1990, Roll No. 112305100336, Category UR, under Post Code 51/21** and return her dossier to the DSSSB.

**Cancellation of offer of Appointment and candidature to the post of TGT(ENGLISH) FEMALE, Post Code 51/21**

Whereas, **Ms. Rahat Jahan, DoB 01.09.1993, Roll No. 112105100194, Category OBC**, has been nominated by the DSSSB to the post of TGT (ENGLISH)-FEMALE against Post Code 51/21 vide Result Notice No. 1408 dated 20/07/2022 in the Directorate of Education, Govt. of NCT of Delhi and their e-dossiers received from DSSSB for further proceedings of appointment. During the Document verification, following deficiencies has been found:

1. NCTE certificate is required
2. NCL Certificate is required before cut of date.
3. NCL Certificate for F.Y. 2022-23 is required.
4. Father name mismatch in 10<sup>th</sup> Certificate.
5. OBC certificate has been issued on the basis of father whose residence of UP, Clarification required.

The candidate has submitted the reply on 10.08.2023 and 06.11.2023 in respect of above deficiencies.

This office has also checked the OBC certificate No. OBC/05/51/11919/11/3/2022/9111013315 dated 16.04.2011 of **Ms. Rahat Jahan** was issued by the Office of the Deputy Commissioner, South District, Delhi on the basis of OBC certificate issued to father of Ms. Rahat Jahan, resident of Vill. Kakrala Distt. Badaui, U.P. who belongs to MOMIN (Ansar, Ansari) Julah Caste which is recognised as Other Backward Class in **the state /U.T. U.P.** issued by the Tehsildar- Defence Colony vide their No. OBC/5/51/9675/22/2/2010/9111004416 dated 19.03.2010.

The instructions issued in the advertisement No. 03/2021 of DSSSB for the post code 51/21 regarding OBC candidates. As per Point 1(iv)- (A) **OBC certificate (Delhi) issued by the Revenue Department of GNCT of Delhi, on the basis of an old certificate issued to any member of individual's family from GNCT of Delhi.** The OBC certificate of the candidate does not fulfil the above instructions as her OBC certificate No. OBC/05/51/9675/22/2/2010/9111004416 dated 19.03.2010 was issued on the basis of her father's OBC certificate issued by the **Tehsildar-Dataganj, U.P.** vide their No. 7838 dated 04.01.1986.

Accordingly, as the candidate has not submitted the requisite document in support of her candidature and not qualified as per the recruitment rules published in advt no. **03/21** issued by the DSSSB for the post concerned, hence, the Director of Education being the Competent Authority ordered to **cancel** the candidature of **Ms. Rahat Jahan, DoB 01.09.1993, Roll No. 112105100194, Category OBC, under Post Code 51/21** and return her dossier to the DSSSB.
