2. The duties, responsibility, objective and functions of the Vigilance Committee at Fair Price Shop Level are as under:-

- (i) To review the activity and responsibility of Fair Price Shop,
- (ii) To review timely delivery and distribution of ration commodities at the Fair Price Shop,
- (iii) To monitor display of ration information at the Fair Price Shop,
- (iv) To ensure maintenance of prescribed the codes at the Fair Price Shop,
- (v) To ensure display of samples of foodgrains being distributed at the Fair Price Shop,
- (vi) To check the quality of food grains received at the shop;
- (vii) To ensure addition and deletion of beneficiaries:
- (viii) To make available suggestions regarding functioning of the shop to the Block Level Vigilance Committee;
- (ix) To ensure compliance of the provisions of Public Distribution System Control Order, the Central Act and the State Act and inform the District Grievance Redressal Officer, in writing, of violation of any provision of the Central Act and the State Act and;
- (x) To inform the District Grievance Redressal Officer, in writing, of any malpractices or misappropriation of funds found by it
- (xi) To regularly supervise the implementation of all schemes

## 3. Meeting Schedule:-

 It shall be ensured by the Member Secretary to hold the meeting of the Vigilance Committee at least once in every quarter and minutes of the meeting is made available to the Block/circle Level Vigilance Committee.
