
**Sub.: Debarment of enlistment for a period of 02 (Two) years in respect of M/s Baba Construction Co. (Prop. Sh. Arun Gupta) Class-II (B&R category) Add. Ground Floor, X/3700, D-1, Gali No.6, Shanti Mohalla, Gandhi Nagar, East Delhi, Delhi-110031**

1. Whereas, the findings of Inquiry Committee and recommendation of Executive Engineer (CD-VII) and Superintending Engineer (FC-II), that necessary action against the agency M/s Baba Construction Co. Prop. Arun Gupta may be initiated as per Enlistment rules of CPWD 2023 in respect of the below mentioned works:

2. Whereas a notice was issued vide this office letter no. T-8(B)/CEF/SSW/SW/DB/2022/9415-19 dated 08.12.2023 to show cause why action for debarment of enlistment from I&FC Department for a period upto 02 (two) years not be taken against you as per relevant rule 13.6 of "Rules of Enlistment of Contractor 2023" on account of "Indulgent of forgery or falsification of records".

3. Whereas the reply submitted by Advocate vide email dated 14.12.2023 has been considered carefully and has not been found upto satisfaction of Empowered Committee and Enlistment Authority.
4. Whereas the Empowered Committee is of the opinion that relevant rule 13.6 "Indulgent of forgery or falsification of records". Therefore, as per relevant rule 13.0, 13.6, the Enlistment Authority on recommendation of Empowered Committee has decided to debar you for a period of 02 (two) years from the date of issue of this order and accordingly, agency shall not be eligible to bid for I&FC department tenders during this period with the other relevant provisions of Rule 13.9 of Enlistment Rule 2023.
5. Further, the Empowered Committee may go in further details for other additional penal action which shall be informed accordingly.
