ORDER

This order will dispose-off the appeal filed by Shri S.M. Qamar in respect of ID. No. 17088(Appeal No. 2149), ID No.17119 & 17128 (Appeal No.2150), ID.No. 17149(Appeal No.2156), ID. No. 17151(Appeal No. 2158).

1. Smt. Chander Kanta, Serton Officer(Admn) present on behalf of DS/SPIO(Admn) and Sh. Shyanu Kumar, Jr. Asst. present on behalf of SPIO/DS (EP) on the date of hearing i.e.10.11.2022.
2. The Applicant Sh. S.M. Qamar was not present on the date of hearing but the he sent a letter/written submission on 01.11.2022 in which it has been requested to decide the matter on suo moto basis.
3. During the hearing, the PIO submitted that four appeals pertains to the same property for which replies have already been given that the information related to Property No. 2506-2507, Baradari, Ballimaran is a third party information & cannot be given. Earlier also many appeals on the same matter have been disposed off on 02.06.2022 & 12.09.2022. The appellant has also approached the CIC in lnd appeal and in one appeal CIC has directed the depts on 08.09.2022 to give reply in 30 days.
4. The DS/SPIO(EP) state that in Compliance of Hon'ble CIC appeal order No. CIC/LABDT/A/20121/153860-UM dated 08.09.2022 in respect of RTI of Sh. S. M. Qamar, a complete and pointwise reply has already been provided to the applicant by the SPIO /DS (EP) under intimation to the CIC.

In view of the above, no merit noticed in appeal. Accordingly, this is dismissed.
