ORDER

This order will dispose-off the appeal filed by Shri S.M. Qamar in respect of RTI ID. No. 17376.

1. Present Smt. Chander kanta, Section Officer (Admn) on behalf of SPIO/DS (Admn) and Sh. Shyanu Kumar, Jr. Asstt. on behalf of SPIO/DS (EP) on the date of hearing i.e.02.03.2023.
2. The Applicant Sh. S.M. Qamar was not present on the date of hearing but he sent a letter/written submission on 20.02.2023 and requested to decide the matter on suo moto basis.
3. Case called.
