In case of absence/leave of Bresiding Officer, Member-1 shall act as Presiding Officer.

The Internal committee shall discharge the following functions:

- Inquire into the complaints of sexual harassment within the Department and report the same to the State Complaints Committee within a specific time frame. For this purpose, sexual harassment includes such unwelcome sexually determined behaviours (whether directly or implication), as:
 - Physical contact and advances.
 - b. A demand or request for sexual favours.
 - c. Sexually colored remarks,
 - d. Showing Pornography.
 - e. Any other unwelcome physical, verbal or non-verbal conduct of sexual nature.
- Recommend the action to be initiated in each case. ii.
- Ensure that the victims or witnesses are not victimized or discriminated against. They iii. shall also examine whether the victim has been discriminated against. They shall also examine the victim should have the option to seek transfer of the perpetrator or their own transfer.
- The Internal Complaints Committee shall submit a detailed quarterly report of the iv. complaints received and the action taken thereof, to the State Complaints Committee, with its headquarter at I.P. Estate, New Delhi.

Presiding Officer and Members shall hold officer for not more than three (03) years. The committee is vested with the powers of Civil Court under the Code of Civil Procedure, 1908. The inquiry may be completed within 90 days.
