ORDER

In pursuance of order No. 6 issued by the Dy. Secretary (Services), Services Department vide their endorsement No.F.13(3)/2021/NFSG/Gr.III(DASS)/Services/Vol III/560-67 dated 23.02.2023, for granting of Non Functional Selection Grade (NFSG) to Gr.III (DASS)/ Senior Assistant officials vide OM No. F.3(5)(1)/NFSG/S.III/2015/987-992 dated 29.04.2015 in accordance with the instructions contained in DoPT, Govt. of India office memorandum no. 20/49/2009-CS-II(B) dated 22.06.2011, the Competent Authority is pleased to grant Non Functional Selection Grade (NFSG) to following Gr.III (DASS)/Sr.Asstt. officials in the Level-6 of pay matrix table under 7th CPC i.e. Rs.35400-112400 (Pre-revised pay scale of Rs.9300-34800 in PB-II with Grade Pay of Rs. 4200/-) w.e.f. the date mentioned against their names:

The above officials may exercise their option, if any, under FR 22 within one month of issuance of the order granting the Non Functional Selection Grade.

Non functional Selection Grade to above mentioned Grade III DASS/Senior Assistants have been granted on the basis of Eligibility List provided by Cadre Controlling Authority i.e Services-II Department, Govt. of NCT of Delhi in terms of No.F.3(5)(1)/NFSG/S.III/2015/987-992 dated 29.04.2015

The grant of NFSG benefits is subject to the condition that if there is a change in the date of eligibility list in respect of any of the above-mentioned Grade-III (DASS)/Senior Assistant in future, due to addition or deletion of names in the eligibility list, they will have no claim over the date of eligibility.

The officials who have been granted MACP benefits in Rs. 2800/- G.P., are not eligible for any increment at the time of pay fixation on grant of NFSG in terms of DOPT, Government of India OM No.25/7/2019-CS.II (B) Dated 27.08.2019, which has been endorsed by Services Department dated 02.02.2021 and accordingly, only the difference in Grade Pay (i.e. 4200-2800-1400) should be allowed.

However, the grant of NFSG is subject to the undertaking that in the event of over payment, which may be detected at a later stage, the same will be recovered from their pay.
