This order shall dispose of the proceedings initiated under rule 20(2) of DCS Rules, 2007 against Smt. Shashi Rani Dua, member of Dakshini Delhi CGHS vide Show Cause Notice dated 16.08.2018.

Whereas, an application was received in public hearing on 07.05.2018 through Advocate Ms. Anupriya Singh on behalf of Sh. P.K. Dhupar under rule 20 of DCS Rules, 2007 read with section 40 of DCS Act, 2003 for disqualification of membership of Smt. Shashi Rani Dua, in Dakshini Delhi CGHS Ltd. alleging that at the time of becoming a member in Dakshini Delhi CGHS Ltd. she was already owning a property in East Punjabi Bagh. Hence, incurred disqualification under the provisions of rule 20 of DCS Rules, 2007.

Whereas, on hearing dated 27.12.2022, it is noted as under:

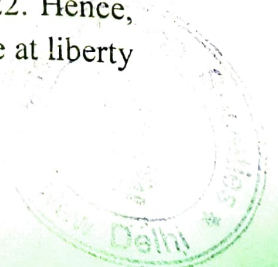

In view of proceedings dated 27.12.2022 wherein the complaint Sh. P.K. Dhupar have submitted that he is not interested in continuing with the present appeal/matter as Smt. Shashi Rani Dua was expired on 22.10.2022. Hence, the present proceedings are dismissed as withdrawn. The parties are at liberty
