This order shall dispose of Review Application U/s 115 of DCS Act, 2003 for review/recall of the order of the RCS dated 24.02.2016 filed by Mrs. U.G. Antony and Cdr. (Retd.) V.K. Jaitely.

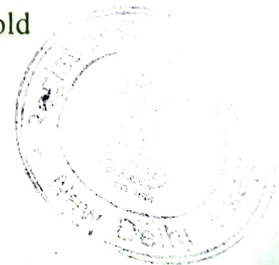
Whereas, a representation/complaint was received from Mrs. U.G. Antony seeking action against Sh. G.N. Kukreti under the provision of section 41 of DCS Act, 2003 read with rule 20(1) (c) of DCS Rules, 2007 for ceasing the membership of Sh. G.N. Kukreti alleging that when he applied for membership in Jaypee CGHS Ltd. he was already a member in Kallol CGHS ltd.

Whereas, after granting an opportunity of personal hearing to the parties and after considering the submissions made by the complaint and the relevant records related to the matter, an order dated 24.02.2016 was passed by the then Secy-Cum-RCS, wherein the proceedings against Sh. G.N. Kekreti are dropped and the petition was disposed of.

Whereas, an application was moved by Mrs. U.G. Antony and Cdr. (Retd.) V.K. Jaitely U/s 115 of DCS Act, 2003 for review/recall of the order dated 24.02.2016 passed by this court. Accordingly, notice for hearing was issued to the parties.

Whereas, replies and rejoinders were filed by both the parties, written arguments were also filed. Whereas, a letter was filed by Sh. Cdr. (Retd.) V.K. Jaitely, informing that he would like to withdraw his complaint regarding alleged fraudulent membership of Mr. G.N. Kukreti, Ex-member of the Jaypee CGHS Ltd. as he has already sold out his flat and no more a member of the society since 01.02.2021.





Whereas, a letter was filed by Sh. Tushar Bhowmick, Secretary of the society informing that Mr. G.N. Kukreti, Ex-member of the Jaypee CGHS Ltd. has already sold out his flat and no more a member of the society with effect from 01.02.2021. As a result the review petition has lost its relevance. He also informs that the society discussed this view with the aggrieved members Mrs. U.G. Antony and Cdr. V.K. Jaitely and both of them are of the same opinion to close this case.

Whereas, a letter has been received from Mrs. U.G. Antony informing that Mr. G.N. Kukreti, Ex-member of the Jaypee CGHS Ltd. as has already sold out his flat and no more a member of the society with effect from 01.02.2021. As a result the review petition has lost its relevance and requested to close this case.

As Sh. G.N. Kukreti against whom the present proceedings under the provision of section 41 of DCS Act, 2003 read with rule 20(1) (c) of DCS Rules, 2007 for ceasing the membership of Sh. G.N. Kukreti are going on has already sold his flat in the society and is no longer a member of the society and the petitioners have also requested to close the case. Hence, in view of the same the present proceedings become infructuous and accordingly, dismissed as withdrawn. The parties are at liberty to avail appropriate legal remedies as per DCS Act, 2003 and Rules, 2007. Ordered accordingly.
