ORDER

Whereas, the Navyug Adarsh CGHS Ltd., F-Block, Vikas Puri, New Delhi – 110018 is registered with this department at Regn. No. 352 under the provisions of DCS Act and Rules.

And whereas, Shri Mahendra Pratap Singh, Retd. Asstt. Director, DDA has been appointed as Administrator-cum-Returning Officer in Navyug Adarsh CGHS Ltd. vide this office order of even no. dated 28/03/2022 and further subsequently extended the tenure of Sh. Mahendra Pratap Singh for 90 days vide dated 12/08/2022.

An honorarium of Rs.10,000/- (Rupees Ten Thousand Only) per month will be given to him for this purpose out of the society funds.
