ORDER

Whereas, the New Saraswati CGHS Ltd, Plot No. 26/1, Sector-IX, Rohini, Delhi-110085 is registered with this department at Regn. No. 467 under the provisions of DCS Act and Rules.

And whereas, the election of the Managing Committee of the said society held on 03/04/2022 was challenged under section 70 of Delhi-Cooperative Societies Act, 2003 titled "Smt. Shashi Runga @ Shashi Devi & Ors.(Claimants) VS Shri B.K. Jha & Anrs. (Respondents)" vide case no. 26/GH/DR/ARB/22-23.

And whereas, Sh. Amresh Kumar Goyal, Arbitrator has passed Award dated 26/12/2022 on Arbitration case No. 26/GH/DR/ARB/22-23 wherein he has opined that *election and all orders passed by the Administrator-cum RO is hereby declared null and void* and requested to the Registrar of Cooperative Societies that the follow the democratic process and keeping in view of rights of the members Administrator-cum Returning Officer should be appointed without any delay.

And whereas, in view of the above facts and circumstances, the Registrar of Cooperative Societies vide order dt. 04.01.2023, appointed Sh. Umesh Batra, Section Officer as Administrator-cum-Returning Officer in New Saraswati CGHS Ltd. under Section 35(5) of DCS Act, 2003, but till date no information has been received from Administrator-cum- RO regarding conduction of election in the concerned society.

Now, therefore, the undersigned is directed to convey the approval accorded by the. Worthy Registrar Cooperative Societies, GNCT of Delhi to appoint Sh. Omkar Singh, Retd. DANICS as Administrator-cum-Returning Officer in New Saraswati CGHS Ltd. under Section 35(5) of DCS Act, 2003 to manage the day-to-day affairs of the society and to hold the election of the Managing Committee of the society as per the guidelines for the elections available under Rule 53 of Schedule II of DCS Rules, 2007 within Ninety (90) days from the date of his appointment. The Administrator-cum-R.O., on expiry of the period of 90 days will not exercise any financial powers till the term is further extended by the Competent Authority. An honorarium of Rs.10, 000/- (Rs. Ten Thousand Only) per Month plus other expenses will be paid to him from the society funds.

This issues with the prior approval of the Competent Authority.
