

Plot-07 Sector 12, Dwarka, New Delhi-110078, stated that all the office bearers of management Committee of the society has submitted their resignation from their respective positions with immediate effect i.e. 27.02.2023 in the best interests of the Society to step down from their roles as President, Vice President and Management Committee members.

Whereas, it has been requested by the outgoing Managing Committee to appoint an Administrator U/s 35(5) of DCS Act, 2003 to look after the day-to-day affairs of the society and to conduct the election of the Managing Committee within 90 days from the issue of this order.

Now, therefore, I, Satish Kumar Gupta, Assistant Registrar (GH/Sec-III) hereby convey the approval of the Competent Authority to appoint Sh.Rakesh Kohli, Sr. Accounts Officer as Administrator in Friends Circle CGHS Ltd. (Regn. No.924-GH) to look after the day-to-day affairs of the society and to conduct the election of the Managing Committee within 90 days from the issue of this order.

He will be paid Rs.10,000/- (Rupees Ten Thousand Only) per month as remuneration from the society funds for this purpose.

This issues with the prior approval of Competent Authority.




