**Order**

This order shall dispose of the proceedings initiated against the Managing Committee of Nangal Dawat Cooperative M.P. Society Ltd. Under section 37(1) of DCS Act 2003 Vide Show Cause Notice dated 02.04.2018.

Whereas, a representation has been received from Sh. Ishwar Singh, President of the society regarding audit to done from 2004-2012.

Further, on inspection it was found that various records have not been maintained/ updated by the society such as Membership register, Proceedings Register & Books of accounts.

Whereas, the society was directed to submit certain documents vide letter no. 284, dated 19.07.2017, but the same were not submitted by the society. Accordingly, Show Cause Notice u/s 37(1) of DCS Act, 2003 were issued against the Managing Committee of the society.

In this regard it is noted that despite several opportunities given to the society no one appeared on behalf of the society. However, a letter dated 05.09.2019 has been received from Sh. Ishwar Singh, President of the society informing that he has been undergoing treatment for the depression from the last one year and because of the same he was unable to attend the hearing and accordingly requested that the matter may be adjourned for 6 months. But, since then neither any one appeared nor any representation has been received from the society.

On hearing dated 31.08.2021 the predecessor of this court has noted that no one has appeared on behalf of the society since issuance of SCN dated 02.04.2018 and accordingly directed that a report may be sought from the Assistant Registrar of the concerned section regarding the term for which noticee Managing Committee was elected, details of last election conducted by the society and term of the present Managing Committee of the society.

Thereafter, the Assistant Registrar of the section has vide letter dated 03.12.2021 submitted that information sought by the RCS is not available in






the file and the same was sought from the society vide letter dated 05.10.2021. But, till date no reply has been received from the society.

It is noted that no one is appearing on behalf of the society nor any reply or any representation has been received from the society. In view of the above, I am of the opinion that a detailed report regarding the functional status of the society may be obtained. Accordingly, DRCS T/C is directed to carry out the inspection of the said society and submit a detailed report regarding the functioning of the society alongwith his comments on the matter. Thereafter, concerned branch may put up the matter for any administrative action on the basis of the report and comments of DRCS (T/C). Accordingly, further proceeding in the court of undersigned is not required in this matter.
