**ORDER**


Whereas, the NCERT Employees Cooperative Thrift & Credit Society Ltd., NIE Campus, Sri Aurobindo Marg, New Delhi-110016 is registered with this department at Regn. No. 266(U) dated 28/09/1970 under the provisions of DCS Act and Rules.

Whereas, Sh. Suresh Chand, F.S.O.(Food and Supplies Department, GNCTD) was appointed as Administrator-cum-Returning Officer in NCERT Employees Cooperative Thrift & Credit Society Ltd. vide office order No. No.F.47/TC/Sec-5/RCS/2022/618-621 dated 09.12.2022.

Whereas, the tenure of Sh. Suresh Chand, F.S.O.(Food and Supplies Department, GNCTD), as an Administrator-cum-RO under section 35(5) of DCS Act, 2003 in the above said society has expired.

Now, therefore, the undersigned is directed to convey the approval of the Competent Authority in exercise of the powers vested in him under DCS Act 2003 & Rules 2007, is pleased to **extend the tenure of Sh.
