ORDER


1. This order shall dispose off the representation dated 18.07.2022 of the Administrator of the society vide which it has submitted requisite documents under section 91 of the DCS Act 2003 and under Rule 92 of the DCS Rules 2007 for obtaining membership of the society by the applicant.
2. The Administrator has submitted copies of documents submitted by the applicant with the application for obtaining membership of the society. An Article/Document Lost in Delhi Report dated 07.07.2022 is placed on record stating that conveyance deed and share certificate (2) for flat no.: 10 has been lost.
