ORDER

Whereas, the NZPH Railways Employees CGHS LTD., Plot No. 7, Geeta Colony, Delhi-110031 is registered with this department at Regn. No. 507/GH under the provisions of DCS Act and Rules.

And whereas, Sh. I.S. Gulati, Retd. ITO was appointed as an Administrator-cum-Returning Officer in place of Sh. B.S. Rana (Retd. DANICS) in the NZPH Railway Employees CGHS Ltd. under section 35(5) of DCS Act, 2003 vide this office order dated 31/08/2022 for the period of 90 days to manage the day-to-day affairs of the society and to hold the election of the Managing Committee.

And whereas, Sh. I.S. Gulati, Retd. ITO has failed to conduct election of the society within stipulated period and also failed to conduct audit of the accounts of the society. However, Sh. I.S. Gulati, Retd. ITO issued Agenda dated 27/02/2023 for conducting election without taking approval of Competent Authority for extension of his tenure as Administrator-cum-RO of the society beyond 90 days i.e. beyond 28.11.2022. Further, Sh. I.S. Gulati, Retd. ITO did not get the audit conducted and also failed to conduct elections of the society within the stipulated period of time as envisaged in schedule-II under Rule 53 of DCS Rules, 2007. Thus, the agenda dated 27/02/2023 issued by Administrator-cum-RO is infructuous and stands invalid.

Now, therefore, the undersigned is directed to convey the approval accorded by the Competent Authority i.e. Worthy Registrar Cooperative Societies, GNCT of Delhi to appoint **Shri K. Panduranga Vithal, AAO (GAD)** as an Administrator-cum-Returning Officer in NZPH Railways Employees CGHS LTD., Plot No. 7, Geeta Colony, Delhi-110031 under Section 35(5) of DCS Act, 2003 to manage the day-to-day affairs of the society and to hold the election of the Managing Committee of the society as per provision of Rule 53 and Schedule II of DCS Rules, 2007. His appointment is made in replacement of Sh. I.S. Gulati, ITO (Retd.), for 90 days from the date of his appointment.. An honorarium of Rs.10,000/-(Rs. Ten Thousand Only) per Month plus other expenses will be paid to him from the society funds.

This issues with the prior-approval of the Competent Authority.
