**ORDER U/S 35 (5) OF DCS ACT, 2003**

Whereas, Delhi Citizen Co-operative Group Housing Society Ltd. is registered vide, registration No.312-GH with this department under the provisions of DCS Act & Rules and Bye-laws of the Society.

And whereas, Sh. Lal Singh, Retd. DANICS was appointed as Administrator-cum-Returning Officer U/s 35(5) of DCS, 2003 vide order dated 25/01/2023 and his tenure has ended without conducting election within the schedule period. Also, Sh. Lal Singh, Retd. DANICS has neither submitted status report on his working as an Administrator-cum- Returning Officer nor sought permission for extension of his tenure.

And whereas, the Registrar Co-operative Societies has now approved the appointment of Shri. Gurbhej Singh Guraya, Addl. Public Prosecutor, Dte. of Prosecution, Govt Of NCT of Delhi as Administrator-cum-Returning Officer of Delhi Citizen Co-operative Group Housing Society Ltd under section 35(5) of DCS Act, 2003 with immediate effect in place of Sh. Lal Singh, Retd. SDM.

And whereas, a remuneration of ₹ 10,000/- (Rupees Ten Thousand Only) per month and Travelling Allowance as applicable shall be paid to him from the funds of the Society.

And whereas, Sh. Lal Singh, Ex-Administrator-cum-Returning Officer of the Society is hereby directed to handover the all records of the Society and other relevant documents to Sh. Gurbhej Singh Guraya, Administrator-cum-Returning Officer, Delhi Citizen Co-operative Group Housing Society Ltd. for conducting election as per Section 35(5) of DCS Act, 2003, Schedule-II of DCS Rules 2007 and Bye-laws of the Society.

This issue with the prior approval of Competent Authority.


