ORDER

Whereas, Fakhruddin Memorial Co-operative Group Housing Society Ltd. is registered vide registration No.582/GH, Plot No.18, Sector 10, Dwarka, New Delhi-110075 with this department under the provisions of DCS Act/Rules & registered Bye-Laws of the society.

Whereas, Sh. G.K. Marwah, Arbitrator in case no. 27/GH/DR/ARB/2017-18 dated 16.10.2018 of Renuka Verma Vs. Fakhruddin Memorial CGHS Ltd. passed an Award (Copy enclosed) wherein it has been judiciously suggested to initiate the Inquiry U/s 62 DCS Act, 2003.

Whereas, the competent authority had appointed Sh. J.B. Kapil, Administrative Officer, DFS as Inquiry Officer U/s 62 of DCS Act, 2003 vide order dated 19.06.2020 but he failed to come to any conclusion after that Sh. Lal Singh, Retd. ADM was appointed as Inquiry Officer vide order dated 07.07.2021 but Inquiry could not be completed due to the non-cooperation of the MC of the society.

Now therefore, I, Satish Kumar Gupta, Assistant Registrar (Section-III) hereby convey the approval of Competent Authority to appoint Sh. Ajay Arora, SDM (Delhi Cantt.), 12/1 Jam Nagar House, New Delhi as Inquiry Officer to conduct Inquiry under Section 62 of DCS Act, 2003, right from the tender process for the construction of different blocks of different categories of flats and cost of construction worked out in respect of each flat till the demands raised to members. The Management Committee of the society shall pay Rs. 15,000/- (Rupees Fifteen Thousand Only) + Other charges as remuneration to Inquiry Officer from the society's fund for conducting the inquiry.
