ORDER

Whereas, Jaina Co-operative Group Housing Society Ltd., Plot No. 26, Sector- 13, Rohini, Delhi - 110085 is registered vide Registration No. 381 with this department under the provisions of Delhi Co-operative Societies Act/Rules & registered Bye-Laws of the Society.

And whereas, this office had appointed Sh. Pritam Singh as Administrator u/s 35(5) of DCS Act, 2003 to conduct the election of Jaina CGHS Ltd. and to hold the election of the Managing Committee of the Society within stipulated period of 90 days from the date of appointment as Administrator subject to the completion of Audit of the Society vide this office order dated 21/07/2022.

And whereas, Sh. Pritam Singh, Administrator could not conduct elections as well as audit of the society.


