Whereas Raksha CGHS Ltd., Pink Apartment, Paschim Vihar, New Delhi-110063 is registered with this department vide registration no. 461(GH.)

Whereas Sh. J.B. Kapil, (Adhoc DANICS) was appointed as Administrator Cum Returning Officer under section 35(5) of DCS Act 2003 vide this office order dated 31.08.2021 to conduct elections for new Managing Committee of the society but elections could not be conducted till date due to various reasons and Sh.
