And whereas, the inspection U/s 61 of DCS Act, 2003 has been conducted by Sh. Shailesh Gupta, (Inspecting Officer) Sr. AO, in Roopvilla CGHS Ltd on the basis of complaint dated 14.05.2018 of Sh. Vishal Kumar.

And whereas, the inspection report filed by Inspecting officer recommended Inquiry U/s 62 of DCS Act 2003. (Copy of complaint dated 14.05.2018 and copy of inspection report dated 26.06.2020 U/s 61 is enclosed)

And whereas, on the basis of Inspection report U/s 61, an Inquiry U/s 62 Of DCS Act, 2003 has been conducted by Sh. Vivek Mittal (Asst. Commissioner, T&T).

Whereas, Inquiry Officer submitted report dated 07/07/2022 with his findings that Sh. Harish Chandra may misappropriate the amount being caretaker in the society who was appointed by the Previous MC of the society and Sh. Ashish Saxena Secretary of previous MC is held responsible for not maintain the proper record of the society. (Copy of Inquiry Report U/s 62 is enclosed)

Now therefore, I Suman Kumari, Assistant Registrar (Section-6) hereby conveys approval of Competent Authority to appoint Sh. R.S. Krishnan (Deputy Secretary, CS Office) as Inquiry Officer under Section 66 of DCS Act, 2003. The Inquiry Officer shall fix the responsibility of person /office bearer of the then Managing Committee for quantum of lapses /misappropriation, if any. Further, the society shall pay Rs. 15,000/- (Rupees Fifteen Thousand Only) as remuneration to Sh. R.S. Krishnan from the funds of the society for conducting the inquiry. The inquiry shall be completed within a period of 45 days of issue of this order.
