**Order under Section 139 of DCS Act, 2003**

Whereas an appeal dated 07/07/2021 has been filed u/s 139 of DCS Act, 2003 by Smt Bimla Devi against the President /Secretary of Vidya Vihar CGHS Ltd. stating non furnishing of the required information to the appellant against his application dated 18/03/2021.

And whereas an order no. F.DR/U/s 139/06/2021/287-288 dated 07/02/2022 was passed by the Appellate Authority inter alia directing the Respondent society to convey in writing the number of pages and requisite fee payable by the appellant. Both the parties were also directed to submit the status of submission of information and society informed about imposition of penalty on society in case it fails to submit reply to appellant within 30 days.

And whereas the appellant vide his letter dated 20/07/2022 had stated that despite the expiry of more than 30 days, she has not received any communication or documents from the said society which indicated that society was not willing to furnish the information to the appellant despite the directions issued by Dy. Registrar vide its order dated 07/02/2022.

And whereas a Show Cause Notice (SCN) dated 04/07/2023 was issued to the President/secretary of the Society to explain as to why penalty in terms of provision of u/s 139 of DCS Act, 2003 read with rule 165 (8) of DCS Rule, 2007 should not be imposed upon him for defaulting in furnishing of information to the Appellant. An opportunity of being heard was also provided to the parties in petition on 13/07/2023.

The hearing conducted on 13/07/2023 was attended by Sh Rajesh Kumar Dudani, counsel for society and Sh. Rajbir Singh Rathi husband of the claimant. Case discussed in detail wherein it was stated by the Respondent that information could not be provided due to non identification/markings of the requisite documents by appellant.



Accordingly it is directed that appellant shall visit the office of society and identify/mark the documents whose copies are required by her through application. The Respondent Society shall calculate the cost of the copies of documents and inform the appellant who will make the payment in advance as per provisions of law. On receipt of the payment the Society shall provide the requisite information in terms of provisions of Section 139 of DCS Act, 2003 under acknowledgement from the appellant. In case of any default in providing the information or non compliance of directions, the parties in petition may re-approach this court as per procedure.

Appeal is disposed of accordingly.
