ORDER U/S 35(5) OF DCS ACT 2003

Whereas, The Dashmesh Co-operative (U) Thrift & Credit Society Ltd. 48-A, Vishwa Karma Park Laxmi Nagar, Delhi-110092 is registered with the office of Registrar Co-operative Societies at Regn. No. 258(T&C) under the provisions of DCS Act 2003 and rules framed thereunder.

And whereas, various communications dated 30/12/22, 24/01/23, 02/03/2023 and 26/05/2023 were received from the members of the society stating therein various irregularities, non conduct of elections and illegal capture of the society arbitrarily by few persons. And also request made for conduct of election and appointment of an Administrator by dissolving the Management Committee reportedly constituted by raising hands on the pattern of past.

And whereas comments were called from the president/secretary of the society vide this office letter dt. 10/04/2023.

And whereas in the reply dated 19/06/2023, received in the name of president of the society, wherein it is stated that Annual Report was not published from very inception. Also details Audit after 2018 have not been provided and election held on 16/10/2022 was conducted on the past pattern as per information received

From the above it is established that election has not been conducted as per the provisions of DCS Act 2003 and Schedule-II of DCS Rules 2007 and other irregularities have been committed in violation of provisions of law.

Now, therefore, the Registrar Co-operative Societies, GNCT of Delhi in exercise of the power vested under DCS Act & Rules, is pleased to appoint **Sh. Shailesh Gupta DCA(Serving)** as Administrator – Cum – Returning Officer in The Dashmesh Co-operative (U) Thrift & Credit Society Ltd U/s 35(5) of DCS Act, 2003, to manage the affairs of the society and to conduct the election of the society, within a period of 90 days from date of receipt of this order. An honorarium of Rs. 10,000/- (Rupees Ten Thousand only), per month plus conveyance will be given to him out of the funds of the society.
