Whereas, SBI Employees CGHS Ltd., Road No. 42, Bank Vihar, Pitampura, New Delhi-110034, registered in this Department vide Regn. No. 581/GH under the provisions of DCS Act & DCS Rules.

Whereas, Sh. Deepak Kumar, S.O. was appointed as Administrator-cum-R.O vide order dated 15/11/23 u/s 35(5) of DCS Act, 2003. However, he has resigned from the post of Administrator-Cum-R.O. on 7/06/2023 due to some personal reasons.

And whereas, the Competent Authority has appointed Sh. Onkar Singh, retd. DANICS, GNCT of Delhi as Administrator-Cum-RO in place Sh. Deepak Kumar, S.O. in aforesaid society u/s 35(5) of DCS Act, 2003 to manage the day to day affairs of the said Society.

Now, therefore, I, Suman Kumari, Asstt. Registrar (H/Sec-VII), do hereby convey the approval of the Registrar Cooperative Societies to appoint Sh. Onkar Singh, Retd. DANICS as Administrator in the SBI Employee CGHS Ltd. under section 35(5) of Delhi Co-op. Societies, Act, 2003, for a period of 90 days to manage the day to day affairs of the society and to conduct the election of the Managing Committee of the society afresh, as per Rule 53 and Schedule II of the DCS Rules, 2007.
