ORDER

Whereas, Hansa CHBS Ltd. was liquidated in 2013 & surplus amount of 42,99,256 of society was deposited in the Cooperative Education Fund O/o of RCS Department vide receipt dated 07.01.2013 & 20.05.2013. The surplus amount of 42,99,256/- was towards the unclaimed amount towards the payment of members, which includes the unclaimed amount of Sh. B.N. Gupta.

As per Rule 113 of DCS Act Rule 2007, this unclaimed amount can be paid within period of three years from the date of liquidation of society. However, there is provision:- **Registrar under special circumstances pay the liabilities claimed even after the stipulated period of three years.**

And whereas, the payment of Sh. R.N. Gupta s/o B.N. Gupta could not be given to him due to legal issue among the legal heir of Sh. B.N. Gupta after his death. Now, case is settled by in the court of Sh. Mridul Gupta, ACJ-cum-ARC (Central), Delhi vide its order dated 13.04.2023. Accordingly, court order grant to 4/5 of total due share of Sh. B.N. Gupta has to be paid to Sh. R.N. Gupta (legal heir) i.e $3,39,216 \times 4/5 = 2,71,292/-$.

Now therefore, I, Satish Kumar Gupta, Assistant Registrar (GH/Sec-III) hereby convey the approval of the Competent Authority to payment of unclaimed amount of Rs. 271292/- of Sh. B.N. Gupta, who was expired, in favour of Sh. R.N. Gupta (legal heir) s/o Sh. B.N. Gupta.

Therefore, he will be paid Rs. 271292/- (Rupees Two Lakh Seventy One Thousand Two Hundred Ninety Two Only) from the Cooperative Education Fund in this regard.

This issues with the prior approval of RCS.


