ORDER

Whereas, Yagya Jyoti CGHS Ltd., 20, Arjun Nagar(Safdarjung Enclave), New Delhi-110029 is registered in this office vide registration No.1458/GH under the provisions of DCS Act/Rules.

Whereas the Society vide letter dated 28.07.2023 has requested this office to appoint Returning Officer for conducting the election of the Managing Committee of the Society. The Society vide letter dated 23.11.2022 has submitted that the last election was held on dated 23.02.2003. This office vide letter 19.10.2005 has directed the then Managing Committee of the Society for not holding election till further instructions by Hon'ble High Court/CBI/Competent Authority as the Society was being investigated by the CBI under 135 Societies.

And whereas in due course of time the Society is cleared by the CBI, which is mentioned in the order issued vide F.No. 47/1458(GH)/Sec-8/RCS/2016/4473-4477 dated 16.04.2018 passed by the then Registrar Cooperative Societies and it should be dealt in parity with the other 19 societies as per the order passed by the then RCS dated 05.09.2012.

And whereas Section 35(5) provides that the committee shall arrange election of the new committee before the expiry of its term and in case the committee fails to do so, the committee shall cease to hold office on the expiry of its term and the affairs of the co-operative society shall be managed by an administrator appointed by the Registrar who shall also hold election within ninety days from the date of his appointment. Therefore, it is expedient in the interest of justice to appoint an Administrator cum R.O. U/s 35(5) of the DCS Act, 2003.

Now, the Competent Authority, GNCT of Delhi, in exercise of the powers vested in him under DCS Act & Rules, is pleased to appoint Sh. Vijender Kumar, Joint Director (H&FW), as Administrator-cum-Returning Officer, in the Yagya Jyoti CGHS Ltd., U/s 35(5) of DCS Act, 2003 to manage the affairs of the society and to hold the election for forming a new Managing Committee of the Society within a period of 90 days from the date of issue of this order. He is further entitled to receive Rs.10,000/- (Rupees Ten Thousand Only) per month as honorarium from the society's funds.

This issues with the prior approval of the Competent Authority.
