**ORDER**

Whereas, Hon'ble Supreme Court of India in Civil Appeal no. 6803-6804/2013 in DDA Vs. Safdarjung CGHS Ltd. & Ors. held that the revival of the society is illegal and the money deposited by it with the DDA for allotment of plot, ought to be refunded with interest for onward refund the depositors.

And whereas, Sh. D. Karthikeyan, ADM (South) DC Office (South), M. B Road, Saket, New Delhi was appointed as Liquidator vide this office order of even number dated 24.04.2019 to initiate liquidation proceedings of the society within six months of taking over charge.

And whereas, vide letter dated 11.09.2023, Sh. D. Karthikeyan, Liquidator/Director, NDMC has intimated that the records of the society have not be handed over to him by the previous Liquidator Sh. S.K. Jha till date and due to heavy workload at office he is relinquishing his charge as Liquidator of the Safdarjung CGHS Ltd. with immediate effect.

Now, therefore, in the exercise of power vested under DCS Act 2003 & Rules 2007, the Registrar Cooperative Societies, GNCTD appoints Sh. T. Tarun Kumar, Deputy Director, GNCTD as Liquidator to initiate the liquidation proceedings as per provisions of Section 100, 101, 102 & 103 of DCS Act 2003.

An honorarium of Rs. 40,000/- (Rs. Forty thousand only) will be payable for this purpose out of the funds of the society and in case such funds are not available with the society, as per Rule 108(4) of DCS Rules 2007, the same maybe permitted to be drawn from the Settlement and Executive Expenses Fund maintained by the Registrar.

This issues with the prior approval of Competent Authority.
