**ORDER**

Whereas, Samrat Ashoka Enclave Cooperative Group Housing Society Ltd., Plot No. 6, Sector 18A, Phase-II, Dwarka, New Delhi-110078, is registered with this Department vide Regn. No. 1407/GH.

And whereas, a representation has been received from the President /Secretary of the society, wherein, it has been requested to appoint a Returning officer to conduct the elections in the society.

And whereas, the last election of the society were held in August 2020 and the MC has already completed its tenure on August 2023.

And whereas, as per section 35(5) of DCS Act, 2003, the Managing Committee of the Society has failed to conduct elections before the expiry of its term and that whosoever R.O. though appointed late, too have resigned.

Now, therefore, I, Suman Kumari, Asstt. Registrar (Section-VII/Housing), O/o RCS do hereby convey the approval of the Registrar Co-operative Societies to appoint Sh. R.S. Krishnan, Dy. Secretary, GNCTD, Administrator in the aforesaid society u/s 35(5) of DCS Act, 2003 to manage the day-to-day affairs of the society and also to conduct election in the Society within a period of ninety days from the date of his appointment. The Administrator shall draw a sum of Rs.10,000/- (Rs. ten thousands only) per month as honorarium alongwith conveyance charges out of the society funds.

The other expenses of the election will be met out from the funds of the society. The election of the Managing Committee of the aforesaid society shall be conducted as per the guidelines for the elections laid down in Rule 53 and of Schedule-II of DCS Rules, 2007.

Further, the Ex-President/Ex-Secretary, MC members of the society are hereby directed to handover all the records/documents of the society to the Administrator within 05 days from the date of receipt of this order.
