Order under Section 139 of DCS Act, 2003

This order shall dispose of the appeal dated 10/01/2023 filed Sh. Ravi Bhushan Bahl r/o R-6, Sahayog CGHS Ltd. (Parvana Vihar), Plot No. 52, Sector-9, Rohini, Delhi-110085, who had sought information u/s 139 of DCS Act, 2003 vide his application dated 14/11/2022 from President, Sahayog CGHS Ltd. (Parvana Vihar). Plot No. 52, Sector-9, Rohini, Delhi-110085. The appellant has stated that management did not furnish complete information as required in form-8 of the Act and Rules, as a result he has not received any information from the Respondent society.

Hearing conducted on 14/08/2023, Sh. Akshay Bhardwaj, Advocate for respondent society and Ms. Pratibha Chopra and Khushboo Bhagat both Advocates for Appellant were appeared for proceedings. During hearing counsel for appellant stated there is no imbrgo on any information u/s 139 of DCS Act, 2003. She cited case of Ms. Eliamma Sebastian V/s Ministry of Home Affairs WP (C) 6532/2013, C.M Nos 14204-14205/2013, 16799/2014 & 20303/2014. She also referred Sch-II of Rule 53 of DCS Rules 2007. Counsel to respondent stated no more submission pending from him and the court may decide on the basis of record and merits. Respondent Society is directed to provide requisite information in terms of provision of Section 139 of the DCS Act, 2003 read with Rule 165 of DCS Rules, 2007 within 7 days of receipt of this order under intimation to this office.

The appeal is disposed of accordingly.
