Order under Section 139 of DCS Act, 2003

This order shall dispose of the appeal dated 16/11/2022 filed Ms. Maya Modak, A-8/52, Sahayog CGHS Ltd. (Parvana Vihar). Plot No. 52, Sector-9, Rohini, Delhi-110085, who has sought information u/s 139 of DCS Act, 2003 vide his application dated 22/09/2022 from President, Sahayog CGHS Ltd. (Parvana Vihar). Plot No. 52, Sector-9, Rohini, Delhi-110085. The appellant has stated that PIO of the society has refused to furnish the desired information.

Hearing conducted on 14/08/2023, wherein Ms. Pratibha Chopra and Khushboo Bhagat both Advocates for Appellant and Sh. Akshay Bhardwaj, Advocate for respondent attended the hearing. Case discussed. Counsel for Appellant stated that information is not barred and there is no imbargo. Section 22 of RTI Act, 2005 is applicable. She stated that this is not third party information and she cited cases of Rattan Gupta V/s Lt Governor, Govt. of NCT of Delhi, WP(C) 6538/2014 & C.M. 15596/2014 decided on 15/01/2016. She also Thalappalam Ser. Coop Bank Ltd and others v/s State of Kerala and others, Civil Appeal Nos 9020,9029 & 9023 of 2013 (Arising out of SLP (C) No 24291 of 2012, 13796 and 13797 of 2013). Also cited Ms Eliamma Sebastian V/s Ministry of Home Affairs and others WP (C) 6532/2013, C.M Nos 14204-14205/2013, 16799/2014 & 20303/2014. Respondent Society is directed to provide requisite information in terms of provision of Section 139 of the DCS Act, 2003 read with Rule 165 of DCS Rules, 2007 within 7 days of receipt of this order under acknowledgement.

The appeal is disposed of accordingly.
