EOI with tender ID No.2022_DWCD_226507_1 was published by this Department on 21/07/22 for supply & distribution of Supplementary Nutritional Food (THR & HCM) under Saksham Anganwadi & Poshan 2.0 to Anganwadi centers in Delhi. The process of EOI was expedited through intense scrutiny having two level of evaluation - an internal committee to evaluate credentials shared in the proposals of bidder organizations and another higher level committee constituted to evaluate capacity and preparedness of applicant organization for undertaking the assignment, wherein an external member was nominated by worthy Chief Secretary (Delhi).

The above mentioned committees have recommended following 11 organizations for award of work and the same has been approved by the Competent Authority.
