
**Notice of termination of service issued under Rule 5(1) of The Central Civil Services (Temporary Service) Rules, 1965.**

Whereas, Shri Jitender (D.O.B-21/01/1996), Grade-IV(GNCTDSS)/Junior Assistant, (Roll No. 11140200267) was nominated by DSSSB for the post. of Grade-IV (GNCTDSS)/Jr. Assistant against post code No.- 02/17. After completing all the codal formalities, the appointment order dated 02.03.2021 was issued to the said Shri Jitender and he joined the DWCD on dated 08.03.2021 (F/N) Shri Jitender was physically posted at Coordination Branch (DWCD HQ) and posted for pay purpose at ICDS Ekta Vihar Project;
2. And whereas, Services Department vide circular No.F.3(1)/2021/PF/S-III/CDNo.081662004 / 2465-2469 dated 27/10/2021 circulated the SoP prepared by of DELHI SUBORDINATE SERVICE SELECTION BOARD vide No.F.55(208)/DSSSB/2020/9788-9800 dated 30.07.2021 and requested to prepare schedule for verification of genuineness of selected and joined candidates for the post code 02/17 & 20/18. The verification of the candidates was carried out by the Departments/Agencies concerned i.e. DSSSB, EdCIL, Services Department on dated 16.11.2021;
3. And whereas, the Services Department, being Cadre Controlling Authority vide No.F.3 (1)/2021/PF/S-III/ 1998-1999 dated 08/09/2022, No.F.55 (273)/DSSSB/Exam/2021/1042 dated 17/08/2022, No. F. 3(1)/2021/PF/S-III/CD No. 081662004/2327 dated 11/10/2021, F. 3(1)/2021/PF/S-III/CD No. 081662004/2465-2469 dated 27/10/2021 & No. F.55(273)/ Exam/ DSSSB/2021/659 dated 02/05/2022 provided the status report of Bio-metric and photograph verification of candidates nominated/joined against post code- 02/17, 20/18 & 21/18, with details of candidates, whose **Bio-metric and Photograph mismatched/ not verified;**
4. And whereas, as per the list of mismatch provided by the Services Department/DSSSB through above cited letter, the Biometric and Photograph in respect of the said Shri Jitender, (Roll No. 11140200267), post code-02/17 were found mismatched during the verification process held on dated 16/11/2021. The details of the said Shri Aakash, Roll No. 11140200267 appear at S. No. 07 in the list of candidates provided by the Services/DSSSB, whose Biometric &

Photograph verification found mismatched/not verified. Further, the Services Department has requested to take necessary action in matter as advised by the DSSSB;

And whereas, the mismatch of Bio-metric and Photograph of the said Shri Jitender, as per report provided by the Services Department, gravitates towards using of unfair means by him in the examination conducted by the DSSSB for the post code 02/17 and hence, his retention in service of the Government is not considered desirable;


