The school premises was re-inspected by the officers concerned of this department on 13/12/2023 in the presence of Sh. Ram Ratan Rai (Security Guard) and found that school building have deemed complied with the fire prevention and fire safety requirement in accordance with Directorate of Education Circular No. F.16/Estate/CC/Fire Safety/2011/3298-3398 dated 01/03/2011 and that the building is fit for occupancy class **Group-B** (Educational) with effect from 29/12/2023 for a period of **three years** in accordance with rule 36 unless renewal under rule 37 or sooner cancelled under rule 40 and subject to compliance of the conditions under rule 38 of the DFS Rules, 2010.

Conditions for the validity of Fire Safety Certificate:

2. All the means of escape / entry / exit shall be kept free from any obstruction.
3. All the fire safety arrangement provided there in shall be maintained in good working conditions at all times.
4. Any loss of life or property due to non-functional fire safety measure shall be at the responsibility of the management.
5. All the staff members must know the correct method of operation of fire fighting system.
6. This fire safety certificate may not in any way be treated as regularization (Clause 2.8 of UBBL-2016) of unauthorized construction or Alteration (Clause 1.4.3. of UBBL-2016), if any.
7. The owner/occupier shall submit a declaration every year in form "K" provided in the first schedule of Delhi Fire Service Rules 2010. The form is available on www.dfs.delhigovt.nic.in.
8. The owner/occupier shall apply for renewal of this Fire Safety Certificate to the Director in Form 'J' [sub rule (1) of rule 37] along with a copy of this Certificate, six months prior to its expiry".

Note: Previously, the school building was issued FSC for Ground and one upper floor vide letter of even No. 584 dated 22/03/2023 and during the inspection conducted by ADO (BCP) on 14.03.2023; the basement floor was found added in the school building. Accordingly, the school management was advised to either restore the earlier composition of the building or submit application for sanction of building plans on common application form (CAF). The school management has submitted that the basement floor is vacant & not in use, as also verified during inspection.

The fire protection systems provided in the building were checked, tested at random and found functional at the time of inspection.

Keeping in view of the deemed compliance of the minimum standards on fire prevention and fire safety measures as required under the rules the fire safety Certificate issued vide letter No. F.6/DFS/MS/School/2019/SZ/584 dated 22/03/2019, renewal under rule 37 of the Delhi Fire Service Rules, 2010 is recommended.
