Certified that the M/s Mayank Guest House located at 2A, Nangli Razapur East Nizamuddin, New Delhi-13, was granted Fire Safety Certificated (FSC) by this department vide letter no. F6/DFS/MS/GH/2021/SZ/17 dated 11.01.2021 for Ground + Two upper floors. The building/premises was re-inspected by Assistant Divisional Officer (M. Road) from this department on 01.01.2023 in presence of Mr. Bhupender Rajpoot (Manager) and found that the building now comprised of **Ground + 04 upper floors: Ground floor-** reception + 02 guest rooms, **1st floor** - 02 guest rooms, **2nd floor-** 02 guest rooms, **3rd floor** - staff room, **4th floor/Terrace** – 01 store room found closed. The building has deemed complied with the fire prevention and fire safety requirements in accordance with Rule 33 of Delhi Fire Service Rules, 2010. The owner has submitted an affidavit on 02.01.2024 not use any floor above third floor for any purpose in accordance with Gazette Notification dated 27.05.2019. Accordingly, the premises is fit for occupancy of **“Residential Sub Division-A-1”** for total **06 Guest rooms (Ground floor-** reception + 02 guest rooms, **1st floor** - 02 guest rooms, **2nd floor-** 02 guest rooms) and valid upto 31.03.2027 in accordance with Rule 36 unless renewed under Rule 37 or sooner cancelled under Rule 40 and subject to conditions under Rule 38 of Delhi Fire service Rules, 2010 printed below.

Conditions for the validity of Fire Safety Certificate

1. This FSC is valid for Ground + Two upper floors only.
2. All the means of escape/entry/exit shall be kept free from any obstruction.
3. All the fire safety arrangements provided therein shall be maintained in good working condition at all times.
4. Any loss of life or property due to non functional fire safety measures shall be at the responsibility of the management.
5. The trained fire fighting staff should be available round the clock.
6. Any deviation w.r.t. construction etc. shall be verified by the concerned building sanctioning authority.
7. This fire safety certificate may not be treated in any case for regularization of unauthorized construction, if any.
8. The owner / occupier shall submit a declaration every year in form 'K' provided in the first schedule of Delhi Fire Service Rules 2010. The form is available on www.dfs.delhigovt.nic.in.
9. The owner/occupier shall apply for renewal of this Fire Safety Certificate to the Director in form 'J' [sub Rule (I) of Rule 37] along with a copy of this Certificate, six month prior to its expiry. Any change in the occupancy shall be intimated to this Deptt. and approval shall be obtained thereto before occupancy of the same.



Note:- There is mentioned of 3rd floor in the building at N/1. However the same has not been mentioned in inspection reports/FSC in subsequent notings. The Guest house is running at Ground + Two uppers floors of the building which is comprised of Ground + 04 upper floors. However one store room at 4th /terrace floor was also seen in the building and same was found closed by the management. The owner has submitted an affidavit on 02.01.2024 not use any floor above third floor for any purpose in accordance with Gazette Notification dated 27.05.2019 placed at C-50 on file.


The fire protection systems provided in the building were tested, checked at random and found functional at the time of inspections.

If agreed to the note above & in view of the deemed compliance of minimum standards of fire prevention and fire safety measures as required under the Rules, the FSC issued vide letter no. F6/DFS/MS/GH/2021/SZ/17 dated 11.01.2021 is recommended to be renewed under Rule 37 of the Delhi Fire Service Rules 2010.
