School No. 1) and 1515021 (SKV) from Delhi Govt. this building was handed over to this school by Sarvodaya Kanya Vidyalaya, Rajouri Garden Extn. New Delhi- 27 (FSC already issued vide letter No. F.6/DFS/MS/School/2022/SZ/515 dated 12.05.2022)
