## Conditions for the validity of Fire Safety Certificate

1. This FSC is valid for 1st & 2nd floors only.

- All the fire safety arrangements provided therein shall be maintained in good working conditions at all times.
- Any loss of life or property due to non functional fire safety measures shall be at the responsibility of the management.
- 4. The trained fire fighting staff should be available round the clock.
- 5. Any deviation w.r.t. construction etc. shall be verified by the concerned building sanctioning authority.
- 6. This fire safety certificate may not be treated in any case for regularization of unauthorized construction, if any.
- 7. Basement shall be used as per NBC/UBBL.
- 8. The owner / occupier shall submit a declaration every year in form 'K' provided in the first schedule of Delhi Fire Service Rules 2010. The form is available on <a href="www.dfs.delhigovt.nic.in">www.dfs.delhigovt.nic.in</a>
- 9. The owner/occupier shall apply for renewal of this Fire Safety Certificate to the Director in form 'J' [sub rule (I) of rule 37] along with a copy of this Certificate, six month prior to its expiry".
- 10. Any change in the occupancy shall be intimated to this Deptt. and approval shall be obtained thereto before occupancy of the same.
