FIRE SAFETY CERTIFICATE

Certified that the M/s Vaishnav Hotel situated at 23 & 640, Fatehpuri, Delhi - 06, comprised of Ground + 04 upper floors, ground floor- (04 guest rooms + reception + 05 rooms for other uses), 1st floor - (09 guest rooms + 01 store), 2nd floor - (08 guest rooms + 01 store + 01 staff room), 3rd floor- (09 guest rooms + 01 linen store) & 4th floor -(not in use), total 30 guest rooms upto 3rd floor was granted FSC by this department vide letter no. F6/DFS/MS/GH/NDZ/2021/418 dated 24.09.2021. The building/ premises was re-inspected by the officer concerned of this department on dated 11.09.2024 in presence of Manager and found that the building has deemed complied with the fire prevention and fire safety requirements in accordance with Rule 33 of Delhi Fire Service Rules, 2010. The owner has submitted an affidavit on 12.09.2024 stating not to use any floor above third floor for any purpose. Accordingly, the premises is fit for occupancy of "Residential (Group-A-1), ground floor - (04 guest rooms), 1st floor - (09 guest rooms), 2nd floor - (08 guest rooms) & 3rd floor - (09 guest rooms) for total 30 guest rooms upto 3rd floor only, with effect from 23/09/2024..... for a period of three years in accordance with Rule 36 unless renewed under Rule 37 or sooner cancelled under Rule 40 and subject to conditions under Rule 38 of Delhi Fire Service Rules, 2010 printed below.

Conditions for the validity of Fire Safety Certificate

4. Any deviation w.r.t. construction etc. shall be verified by the concerned building sanctioning authority.
5. This fire safety certificate may not be treated in any case for regularization of unauthorized construction, if any.
6. The owner / occupier shall submit a declaration every year in form 'K' provided in the first schedule of Delhi Fire Service Rules 2010. The form is available on www.dfs.delhigovt.nic.in.
7. The means of escape shall be kept unobstructed / unlocked for unhindered evacuation in case of an emergency.
8. The owner/occupier shall apply for renewal of this Fire Safety Certificate to the Director in form 'J' [sub Rule (I) of Rule 37] along with a copy of this Certificate, six month prior to its expiry. Any change in the occupancy shall be intimated to this Deptt. and approval shall be obtained thereto before occupancy of the same.
9. The occupancy of above 3rd floor not allowed as per clause 7.31 in UBBL-2016.
