Certified that the **Green Valley Public School** located at **Hari Nagar, Jaitpur Road, Badarpur, New Delhi-44**, comprised of comprised of Two blocks A- Block Ground floor only & B - Block - Ground + 01 upper floor, was granted Fire Safety Certificate by this department vide letter no. F.6/DFS/MS/School/2021/SZ/931 dated 12.11.2021. The school building was re-inspected by Assistant Divisional Officer (M. Road) from this department on 01.10.2024 in the presence of Mr. Nitin Chopra (Vice Principal) and found that school building is now comprised of Two blocks A- **Block Ground + 01 upper floor (1<sup>st</sup> floor vacant) & B - Block - Ground + 02 upper floors** and found that the building has deemed complied with the fire prevention and fire safety requirements in accordance with Rule 33 of Delhi Fire Service Rules, 2010. Accordingly, the premises/building is fit for occupancy of Group B "Educational Building" (School) with effect from 04/10/2024 for a period of three years in accordance with Rule 36 unless renewed under Rule 37 or sooner cancelled under Rule 40 and subject to conditions under Rule 38 of Delhi Fire Service Rules, 2010 printed below.

**Conditions for the validity of Fire Safety Certificate**

1. All the means of escape shall be kept free of all the type of obstruction all the time.
2. All the employees shall be acquainted with the use and maintenance of all fire equipments and method of smooth and speedy safe evacuation of occupants in case of emergency.
3. All the fire fighting equipments shall be maintained in perfect working condition all the time and any lapse rendering non-functional of fire safety measures, management shall be responsible.
4. The clarification with regards electrical installation, ventilation, structure stability set back areas, occupancy and constructional deviation in building etc .may be got verified from the authorities concerned.
5. This Fire Safety Certificate cannot be treated in any case for regularizations of unauthorized construction unauthorized use of land if any.
6. The owner / occupier shall submit a declaration every year in form 'K' provided in the first schedule of Delhi Fire Service Rule 2010. The form is available on [www.dfs.delhigovt.nic.in](http://www.dfs.delhigovt.nic.in).
7. The owner /occupier shall apply for renewal of this fire safety certificate to the Director in form J' [sub Rule (1) of Rule 37] along with a copy of this certificate, six months prior to its expiry.

**Note:-** In the previous inspection report the building is comprised of Two blocks A Block - Ground floor only & B Block - Ground + 01 upper floor while during inspection dated 01.10.2024 school building was found comprised of Two blocks A Block - Ground + 01 upper floor (1<sup>st</sup> floor vacant) & B Block - Ground + 02 upper floors. Thus this is a case of addition/alteration hence inspection has been conducted as per UBBL 2016/NBC- Part IV.


The fire safety provisions provided in the building were randomly tested, checked and found functional at the time of inspection.

If agreed to the note above & in view of the deemed compliance of minimum standards of fire prevention and fire safety measures as required under the Rules, the FSC issued vide letter F.6/DFS/MS/School/2021/SZ/931 dated 12.11.2021 is recommended to be renewed for Two blocks A Block - Ground + 01 upper floor (1<sup>st</sup> floor vacant) & B Block - Ground + 02 upper floors under Rule 35 of the Delhi Fire Service Rules 2010.
