Conditions for the validity of Fire Safety Certificate

- No trade susceptible to cause to CNG by generating head, mechanical/ electrical spark should be allowed within the licensed premises.
- Overhead electrical cable and loose/naked wiring shall not be allowed across the licensed premises. The electrical equipment, electrical gadgets and fitting in the premises shall conform to hazardous area classification for the at purpose and be of a type approved by the CCE.
- 3. In premises "NO Smoking" signs board both Hindi and English shall be displayed in such a manner as to be easily readable by all people.
- 4. All the employees shall be acquainted with the use and maintenance of all fire equipment's and method of smooth and speedy safe evacuation of occupants in case of emergency.
- 5. All the firefighting equipment's shall be maintained in perfect working condition all the time and any lapse rendering non-functional of fire safety measures, management shall be responsible.
- 6. Noting contravention of the explosive Act. 1884 and rules their under 1983, and static mobile pressure vessels (Unfired) Rules 1981 as modified from time to time.
- 7. Any deviation, with regards to construction, ventilation, occupancy, electric installation etc. May be got verified from the concerned authorities..
- 8. This Fire Safety Certificate may not be treated in any case for regularizations of unauthorized construction/ unauthorized use of land if any.
- 9. The owner / occupier shall submit a declaration every year in form 'K' provided in the first schedule of Delhi Fire Service Rule 2010. The form is available on www.dfs.delhigovt.nic.in.
- 10. The owner/occupier shall apply for renewal of this Fire Safety Certificate of the Director in Form 'J' [Sub rule (1) of rule (37)] along with a copy of this Certificate, Six Months prior to its expiry.
