Now the management of Shibban Modern Secondary Public School and Vijay Jyoti Co-Edu. Middle School (Which is approachable through 6.0 meters wide road and has been issued FSC vide letter no. F6/DFS/MS/School/NDZ/2024/488 dated 03.06.2024, is adjacent to Shibban Modern Secondary Public School) have made an agreement (C-79 to C-82) that Vijay Jyoti Co-Edu. Middle School will have no objection to allow Delhi Fire Service department, to use the premise of their school for the fire engines of Delhi Fire Service, in case any fire emergency arise in Shibban Modern Secondary Public School, Vijay Colony Jagjeet Nagar, New Usmanpur Delhi-110053.

However, the same request was received from the school management (C/56)earlier also but was not accepted by the then DCFO/NDZ (N/30).

The fire protection system was randomly checked and tested and was found functional at the time of inspection. The earlier shortcomings issued vide letter no. F6/DFS/MS/School/2021/80 dated 17.02.2021 by this department have been rectified by the management. If agreed, same may be considered.

Keeping in view of the substantial compliance of the minimum standards of fire prevention and fire safety required under the rules and note written above, it is recommended to consider the request for grant of Fire Safety Certificate under rule 35 of the Delhi Fire Service Rules 2010 is recommended.

No file is pending with me before disposal of this case.
