Baxla (Principal) of the school and found that the school building have deemed complied with the fire prevention and fire safety requirements in accordance with rules 33 of the Delhi Fire Service, 2010 and observed that the school building is fit for ground plus three upper floors in two blocks occupancy class "B" Educational Building with effect from 30/10/2024 for a period of three years in accordance with the rule 36 unless renewed under Rule 37 of sooner cancelled under Rule 40 and subject to compliance of the conditions under rule 38 of the Delhi Fire Service-Rules, 2010 printed bellow.

- 6. This Fire Safety Certificate cannot be treated in any case for regularizations of unauthorized construction unauthorized use of land if any.
