**Subject: - Sanction to engage Un-Skilled workers on contract basis.**

Competent authority vide orders dated 15.02.2024 approved the sanction for engagement of 580 Nos. Un-Skilled workers through contractor for a period of six month for sewer and water network maintenance purpose. Accordingly, Un-skilled workers for each maintenance circle for maintenance of water supply and sewerage networks together are allowed to engage through contractors strictly by e-tendering/GeM. SE(M)s are advised to use them judiciously for maintenance of water and sewer network as per requirement.

Concerned divisions shall ensure payment of minimum wages to unskilled workers engaged through contractors, as applicable in Govt. of NCT of Delhi, along with compliance of all codal formalities, provisions of GFR, CPWD manual, CVC guidelines and extent instructions with respect with to due diligence and financial prudence issued from time to time by various authorities.

Further as desired by CEO, DJB all maintenance divisions are directed to put up status/progress note regarding number of complaints received, resolve and pending for
