4. Fee for Interim / Misc Applications, Reply / Rejoinder to Interim / Misc Applications – Rs. 55,000/- per draft
5. Fee for Drafting of Clarification Letters / e-mails / Cost Submissions to the Tribunal – Rs. 15,000/-
6. Clerkage @ 10% of appearance fee
7. Misc. Expenses – As per actual

It is clarified that single fees shall be paid to the counsel(s) if both the claim cases are heard collectively by the Tribunal.
