Further, they will get 10% enhancement of remuneration as per Office Order No. 235(Min) dated 05/11/2021 issued from the office of AC(D), DJB and will be paid remuneration as per the actual attendance duly verified by the DDO concerned.

The engagement of the aforesaid persons on contract basis will be subject to the following terms and conditions: -

1. No other allowances, what so ever, will be admissible/paid.
2. The payment/remuneration indicated above will be inclusive of all services mentioned here in before and no extra payments will be made.
3. It is made abundantly clear that the assignment is purely on contractual nature and confers no right of appointment or placement in Delhi Jal Board or any other department under Govt. of NCT of Delhi. Their services will be utilized on a contractual basis depending upon the need and their payment will be made accordingly.
4. The department shall monitor their performance and further extension of contractual engagement will depend upon their performance. The decision of the administration of DJB will be final in this case. Their appointment on a contract basis may be terminated at any time in case their performance/attitude are found unsatisfactory without any notice.
5. The department will not bear any kind of liability/responsibility during the period they remain on contractual appointment with Delhi Jal Board except payment of monthly contractual remuneration.
6. They will not be entitled to claim for any extension of the contractual engagement of their service.

7. DJB will not hold any responsibility for any incident/accident occurred during their contract period-
8. The above period of engagement of contract may be extended or curtailed at the sole discretions of the Competent Authority.
9. Only one day C.L. in a month will be admissible to the contractual employees, which could be carried forward to the following months.
