Sub: Engagement of DEOs on outsource basis in the Revenue Department-reg.

Sir/Madam,

I am directed to convey the approval of ACS (Revenue)-cum-Divisional Commissioner, Govt. of NCT of Delhi, in continuation of the Finance Department, Govt. of NCT of Delhi, vide their U. O. NO. 286/DS 6 dated 08.03.2016, and granting of NOC of Services Department, GNCTD vide Dy. Secretary (Services)'s letter no. F.4/2/2021/S-II/872 dated 15.03.2024 (copy enclosed for compliance of instructions therein), towards hiring of 294 (Two Hundred and Ninety Four) DEOs against the vacant posts of Senior Assistant, Junior Assistant and Stenographer Grade III, on outsource basis for the period w.e.f. **01.03.2024 to 28.02.2025**, or till the regular incumbents are posted by Services Department, whichever is earlier. The districts shall engage the DEOs on outsource basis through GeM only, subject to observance of all codal formalities and availability of funds.

The District Authorities would ensure that all the conditions are fulfilled and guidelines are followed regarding the mode of hiring and deployment of outsource staff. **It may also be ensured that these outsourced staff are deployed for non-sensitive work and to their engagement in corruption-prone work in Revenue Districts should be avoided.** Further, the above approval is subject to fulfillment of all codal formalities, financial rules and regulations, GFR, Circulars/OMs/Directives etc., issued by CVC/Government of India & Govt. of NCT of Delhi in letter & spirit without fail. **The district concerned may also ensure that total number of DEOs hired on outsource basis against the vacant posts of Sr. Asst./Jr. Asst./Stenographer Gr-III should not exceed total vacant posts of Sr. Asst./Jr. Asst./Stenographer Gr-III at any stage.** The above outsourced staff shall be paid against vacant posts only.

The rates in r/o outsource staff detailed above will be revised as and when the minimum wages rate are revised by Labour Department, Govt. of NCT of Delhi.




