Cancellation of offer of Appointment and candidature to the post of TGT(ENGLISH) FEMALE, Post Code 51/21

Whereas, Ms. Kiri, DoB 23.05.1993, Roll No. 121105100165, Category OBC, has been nominated by the DSSSB to the post of TGT (ENGLISH)-FEMALE against Post Code 51/21 vide Result Notice No. 1408 dated 20/07/2022 in the Directorate of Education, Govt. of NCT of Delhi and their e-dossiers received from DSSSB for futher procedings of appointment. During the Document verification, following defeciencies has been found:

- 1. NCL before cut of date is required.
- 2. NCL for F.Y. 2022-23 is required.
- 3. NCL for F.Y. 2023-24 is required
- 4. Candidate's aggregate marks in graduation are 44.75%. Hence clarification as per RR's of TGT (English) Female is required.

The candidate has submitted the requisite documents in respect of deficiencies mentioned at S.No. 1 to 3. Regarding Point No. 4, the candidate stated that her MA (English) degree is from Karnataka State Open University. But the university is discontinued recognition of programme through ODL Mode beyond 2012-13 by the UGC. Ms Kirti has done her MA English in 2013-15.

It is clear that Ms. Kirti does not fulfil the requirements of graduation as per the RRs as she secured 44.75% in graduation and minimum requirement is 45% and also her MA English from Karnataka State Open University in the session 2013-15 is not valid as per the UGC Public Notice dated 16.06.2015 and also Karnataka State Open University declined to issue MA English degree to Ms Kirti vide letter dated 03.06.2022 citing the UGC instructions.

Accordingly, as the candidate is not eligibile to the post of TGT (English) Female, Post Code 51/21 hence, the Director of Education being the Competent Authority ordered to cancel the candidature of Ms. Kiri, DoB 23.05.1993, Roll No. 121105100165, Category OBC under Post Code 51/21 and return her dossier to the DSSSB.

This issues with the prior approval of the Competent Authority.
