ORDER

CANCELLATION OF CANDIDATURE FOR THE POST OF TGT (NATURAL SCIENCE) POST CODE-36/21

Whereas, the following candidates were nominated for the post of TGT (Natural Science) under the post code 36/21 (as per vacancy advertisement no. 02/21) by the Selection Mechanism Authority i.e. DSSSB vide Result No.130 dated 26/04/2022 and their e-dossiers received from DSSSB for further proceedings of appointment.

Whereas, During the due course of documents verification, it was noticed that the following candidates do not have essential qualification as per notified Recruitment Rules for the said post i.e. TGT (Natural Science) under post code 36/21 and deficiency memo were issued to them thereby.

And whereas, Two Expert Committee were formed by the Competent Authority one after the other, for the purpose of taking a View a holistic & diverse view as to whether the candidate(s) possessing B.Tech or Bachelor of Pharmacy or B.Sc. (Hons.) Electronics/Mathematics qualification is eligible for the post of TGT (NS) or their possessed qualification is equivalent to the required essential qualification in terms of subject studied during graduation course prescribed in the Recruitment Rules for the post of TGT (Natural Science).

It is concluded that the Candidates cannot be considered as the candidate does not have essential qualification as per set Recruitment Rule for the said post i.e. TGT (Natural Science) under post code 36/21.

And whereas, Both the Committee recommended the following conclusion after the thorough inspection of the different cases on the basis of acquired education:

The conclusion of both committees were: *"As per the Recruitment Rules for the post of TGT Natural Science, the candidate is required to study one of the main subjects i.e. Physics/ Chemistry/Biology/Botany/Zoology for at-least Two years during the graduation course. From the above Table, it may be concluded that none of the above candidates has studied single main subject for at-least two years, thus, the Committee is unanimously of the view that the candidature of the candidates assessed cannot be considered for the post of TGT Natural Science under Post Code 35/21 and 36/21 on the ground that the aforesaid candidates do not fulfil the eligibility criteria of essential qualifications as per Recruitment Rules for the post of TGT Natural Science."*

Now whereas, consequent upon the recommendation of the expert committee, the Offer of Appointment letters issued to the above mentioned candidates are hereby withdrawn and their Candidature stand cancelled, accordingly. No further correspondence in this regard will be entertained by this department in future. Candidates E-dossier files are being sent to DSSSB for further necessary action at their end.




