ORDER

WITHDRAWAL OF OFFER OF APPOINTMENT FOR THE POST OF TGT (SANSKRIT) FEMALE,
POST CODE -55/21

Whereas, DSSSB published the 1159 vacancies (EWS-33, UR-527, OBC-281, SC-206 and ST-112 including PH-OH-26, PH-VH-25) vide letter no. F.1(604)/P&P/DSSSB/2021/Advt./5162 dated 27.05.2021, post code 55/21 of Advertisement No. 03/2021 and declared the result of 944 (out of 1159) provisionally nominated candidates vide result notice No. 167 dated 16.08.2022. DSSSB vide letter No. F.4(333)/P&P/DSSSB/2019/336 dated 24.08.2022 forwarded the e-dossiers of 944 candidates (UR-516, OBC-88, SC-206, ST-110, EWS-11 & PWD-13) for further process of appointment.

Whereas, Ms. Priya Meena (DOB: 22/07/1998), having Roll No. 111105500060 was nominated provisionally in waiting list at serial no. 06 under ST category by the Selection Mechanism Authority i.e. DSSSB for the post of TGT (Sanskrit) Female under the post code of 55/21 vide Letter No. F.No.4(37)/DSSSB/CC-IV/2021/2025-2034 dated 16.08.2022 (as per vacancy advertisement no. 03/21) vide result notice No. 167 dated 16.08.2022.

And whereas, one candidate was initially nominated in ST-PH category and later by the approval of competent authority, her category was changed from ST-PH to SC-PH which was the actual category of this candidate. Further, it was inadvertently presumed that a seat in ST category have fallen vacant as there is no waiting in PH category and offer of appointment was issued accordingly to the very next candidate in ST category namely Ms. Priya Meena (Roll No. 111105500060) vide order/letter no. F. No.DE.3 (42)/DRC/E-III/TGT(SANSKRIT)/FEMALE/2022/70333 dated 01/08/2023. However, the post was reserved for (PH) category.

Since, post of TGT (Sanskrit)-Female, post code 55/21 under ST Category is not vacant, Offer of Appointment issued to Ms. Priya Meena was required to be withdrawn.

Whereas, case of Ms. Priya Meena (DOB: 22/07/1998), having Roll No. 111105500060 was processed and putup for the appraisal of Competent Authority regarding withdrawal of Offer of Appointment issued to Ms. Priya Meena inadvertently.




Whereas, the Directorate of Education examined the case in detail and the competent authority granted approval for withdrawal of Offer of Appointment issued to Ms. Priya Meena as the same was issued inadvertently as post of TGT (Sanskrit)- Female under the Post Code 55/21 under ST Category is not vacant.

Therefore, in view of the above facts and circumstances as stated above, Offer of Appointment issued to Ms. Priya Meena (DOB: 22/07/1998), having Roll No. 111105500060 is hereby withdrawn with retrospective effect for the post of TGT (Sanskrit)-Female under the Post Code 55/21 under ST Category.

"No claim for appointment, if so, made at any later stage on the basis of any ground by the candidate will be entertained by the Department, in future."

This issues with the prior approval of Competent Authority.
