ORDER

**Cancellation of offer of Appointment and candidature to the post of PGT(ECONOMICS)
MALE, POST Code 66/20**

Whereas, **Sh. PAWAN KUMAR, D.O.B. 13/08/1988, Roll No. 111806600148** has been nominated by the DSSSB to the post of PGT(ECONOMICS)-MALE against Post Code 66/20 vide Result Notice No.1419 dated 22/12/2021 in the Directorate of Education, Govt. of NCT of Delhi.

Whereas, the candidate was appointed/posted at New Ashok Nagar-GBSSS-1002187 vide Order No: F.NO.DE-2(63)/DRC(E-II)/PGT(ECONOMICS)/MALE/2021/3643 dated: 31/05/2023 (Posting ID: 20230451), with the direction to join his place of posting latest by 01/07/2023.

Whereas, Final Notice (last opportunity) of joining was issued vide order No: F.NO.DE-2(63)/DRC(E-II)/PGT(ECONOMICS)/MALE/2021/2190 dated: 11/12/2023 to join within 15 days.

And Whereas, **Sh. PAWAN KUMAR** has also given his declaration via email dated 25th Jan 2024 where the candidate has stated that "I Pawan Kumar S/o Sh. Satpal Singh Empl. Id-20232566, want to inform you that due to PERSONAL REASONS, I don't want to join the post PGT ECONOMIC POST CODE 66/20 posted at New Ashok Nagar School. Please consider my request and do the needful at the earliest."

As per DOPT OM no. 35016/2/93-Estt.(D) dated 09.08.1995, the following has been mentioned:

"An offer of appointment should clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specified period. If however with the specified period a request is received from the candidate for extension of time, It may be considered by the Ministry/Department but extension beyond 3 months should not be granted liberally and it may be granted only as an exception where facts and circumstances so warrant and in any case only upto a maximum period of 6 months from the date of issue of original offer of an appointment". An offer of appointment would lapse automatically after the expiry of 6 months from the date of issue of the original offer of appointment.

Therefore it is evident that the candidate is no longer interested in joining the above mentioned post. Hence, the Director (Education) being the Competent Authority ordered to **cancel** the candidature of **Sh. PAWAN KUMAR, D.O.B. 13/08/1988, Roll No. 111806600148, Post PGT(ECONOMICS)-MALE, Post Code 66/20** and return his dossier to the DSSSB.

This issues with the prior approval of the Competent Authority.
